Economic Impact Rebates, Financial Advice, H&S Cares, Re-Opening plans, & more!

"The more things change, the more they stay the same." Communication has always been the hallmark of success in life and business. Accordingly, we are reaching out to you once again to relay some very important new developments.

Individual Economic Impact (EI) Rebates:

- The IRS has established a "Get My Payment" section on its website to check the status of your rebate. There is also a Q&A section. You can access this directly or from the H&S website. Visit https://www.irs.gov/coronavirus/ economic-impact-payments
- What if the income used by the IRS (2018 or 2019) was too much for me to receive an El payment or caused my payment to be reduced? If it turns out that your 2020 AGI would yield an El rebate or larger payment you will receive



the additional rebate when filing your 2020 return!



And if the opposite happens you will not be penalized. No reductions are to occur at a later time.

- You may want to discuss possibly revising your estimated tax payments for 2020 for a variety of reasons such as:
 - Lower income anticipated in 2020
 - Less capital gains in 2020
 - Deciding not to take your RMD in 2020 (see below)
 - Other issues?

Caution - unemployment is fully taxable for federal and state tax purposes

Financial Advisor/Advice

As noted above, your finances and their tax consequences have likely changed in 2020. If you haven't reached out to

your financial advisor yet, we encourage you to do so. If you do not have an advisor, you can look to your H&S CPA for recommendations.



Estimated Tax Payments

In our last communication we reported that 2nd guarter federal tax estimates were still due June 15th. This has now been revised such that any balance due on



your 2019 tax return along with your 1^{st} and 2^{nd} quarter federal estimates are now all due July 15, 2020. Michigan has yet to move their 2nd guarter estimate due date to June 15th, however, we expect that may yet occur. In any event, there's an easy work around by doubling your 1st quarter estimate due July 15th and skipping your 2nd quarter Michigan estimate.

Reminders from our last communication:

- Required Minimum Distributions (RMD's): These are suspended for 2020
- 401k Loans: Loan limits increased and payment terms extended
- Charitable Contributions: New "above the line" deduction up to \$300 in 2020 for those who don't itemize (See below for an opportunity to double your contribution dollars)



Tax Returns

While many of us are now working remotely, we are ready and able to prepare your return. July 15th will come sooner than we think, especially once the "stay at home" order is lifted, huh?



There is certainly no reason to wait if you are expecting a refund or even if a tax due is anticipated. With so many payments coming due July 15th, it is all the more reason to plan for sooner rather than later! So, we encourage you to drop off or mail your returns to us as soon as possible.
