PPP / ERTC / EIDL Update:

Paycheck Protection Program Flexibility Act of 2020

Passed by Congress on June 3rd and signed into law by President Trump on June 5th, the Paycheck Protection
Program Flexibility Act of 2020 further expands economic relief available to small businesses impacted by
the COVID-19 pandemic. Our team reviews this legislation and other significant developments impacting your
business below.

PPP/ERTC Updates:

- The covered loan period for the PPP program has been extended from 8 weeks to 24 weeks. This will greatly expand the ability of businesses to have PPP funds completely forgiven.
- To qualify for complete loan forgiveness, only 60% of the loan proceeds spent over the new 24-week period must be spent on payroll costs (down from 75%)
- With PPP funds still available, now may be the time to reconsider applying for a PPP loan. Those who have already claimed the ERTC tax credit should consult with H&S first to determine if they should repay any ERTC tax credit received in order to apply for a PPP loan.

SBA Disaster Loans Update:

The SBA has been sending notices of EIDL offers to those who applied for the \$10,000 Emergency Grant. The
offers are for a maximum of \$150,000, include a one-year payment deferral, 30-year term, 3.75% interest, no
personal guarantees, a maximum \$100 loan fee, and no pre-payment penalties. If you haven't yet received an
offer, call the SBA at 1-800-659-2955.
